Tracsis Rail Technology & Services Limited began calculating its scope 1 and 2 emissions and one category of Scope 3 emissions in 2022. For the current emission reporting the reporting entity uses data collated from their financial year 2023/2024<sup>1</sup> and the ultimate parent company's Annual Report for 2024<sup>2</sup>. The data from FY 2023/2024 marks the first year that the Tracsis plc group of companies migrated to an integrated financial system, which increased the number of scope 3 categories that could be reported.



The following environmental management measures and projects have been completed or implemented since the 2022 baseline.

#### ISO14001 Certified

We achieved pan-group certification across our UK operations in 2023, overseen by our Group Environmental Manager. Our ISO 14001-certified Environmental Management System enables us to monitor, control, and continuously improve our environmental performance.

#### Switch to renewable energy

Tracsis Rail Technology & Services Limited are in direct control of the energy provider and have switched their electricity tariff to renewable energy.

### E-vehicle purchase scheme

Our parent company introduced an e-vehicle salary sacrifice scheme administered by Tusker. The scheme allows employees to get a new, fully insured and maintained EV at a reduced cost.

# Future carbon reduction initiatives Value Chain engagement

To build strong supplier relationships, we will collaborate with our suppliers to understand our Scope 3 emission sources and set targets with them to reduce and mitigate those emissions.
